#### **COLLECTION NOTICE**

The VCAA is a statutory authority continued under the Education and Training Reform Act 2006 (Vic). Language learner statuses are required to be entered on VASS before the enrolment deadline for VCE Unit 3–4 sequences, Friday 2 May 2025.

# Why do students need to complete this declaration?

All students are required to complete this Declaration before enrolling in Units 3 and 4 of a VCE Modern Language study.

Schools then record the declared status of each student as either a First Language Learner or a Second Language Learner.

First and Second Language Learners follow the same curriculum and sit the same examinations.

For each applicable study, study scores will be calculated based on Second Language Learners. The outcomes from these calculations will then be applied to all students. This process maintains the rank order of all students within the study but ensures that the study scores of Second Language Learners are not impacted by First Language Learners.
