#### **Representation 2**

#### Pets are no longer in the doghouse

Victorian renters are set to have greater rights when it comes to their pets. In October 2017, the Victorian Government announced 14 rental reforms in its Rent Fair package, including making it harder for landlords to ban pets.

The reforms came five months after the formation of the Make Renting Fair Coalition (MRFC). The MRFC, led by Tenants Victoria, includes over 70 organisations and 4000 individuals, and aims to provide Victoria's 1.5 million renters with better protections.

The MRFC developed a campaign seeking changes to the *Residential Tenancies Act*. The changes, presented as a policy platform, included removing 'no reason' eviction notices, banning rental bidding and allowing pets.

The campaign is part of a bigger movement for more pet-friendly rental accommodation, which includes the 'Keep Australia Pet Friendly' campaign championed by celebrity vet Dr Chris Brown.

Tenants Victoria CEO Mark O'Brien says, 'We are very proud that support of the Make Renting Fair campaign over the past nine months has driven the Victorian Government in the right direction'.

The community response to the government's reforms has been huge, with over 800 people within one week emailing their support, in particular for the 'pets are welcome' promise, to various members of the Victorian Government.



When launching the reforms, Minister for Agriculture Jaala Pulford stated, 'No one should have to choose between the pet they love and a place to live – our reforms will end this discrimination'.

However, not everyone supports the reforms. The Real Estate Institute of Victoria (REIV) has set up the 'Rentfair is Unfair' online petition, claiming landlords may be negatively affected by the changes. They allege some landlords have already stopped renting out their properties to avoid pets. Fewer properties on the market worsens the housing affordability crisis by reducing supply, which leads to higher rents and to greater competition between renters.

The work of the MRFC is not done until the reforms are legislated in a revised *Residential Tenancies Act*.


