## **Collection Notice**

The Victorian Curriculum and Assessment Authority (VCAA) is a statutory authority continued under the *Education and Training Reform Act 2006* (Vic). The application is to be completed by all students who wish to enrol in English as an Additional Language (EAL) Units 3 and 4 in 2024 and must be returned to the home school for the required endorsement by the principal or delegate prior to the student commencing their VCE program.

Eligibility to enrol in EAL is usually determined by schools and in these cases, the application must be retained at the home school with copies of the required supporting documentation. These applications do not need to be forwarded to the VCAA.

If a decision is not clear, or if the application is for a student whose country of origin is Singapore or India then it must be forwarded with the required supporting documentation to the VCAA for assessment. These applications should be submitted by Friday 13 October 2023 to Student Records and Results Unit, via email to student.records@education.vic.gov.au or by fax to (03) 9032 1591.
